Report of the Head of Pensions

Purpose of Report

- 1. At the Annual Meeting of the Borough Council, it is usual for the Council to approve the programme of meetings for the municipal year ahead. This would include meetings of the Local Pension Board.
- 2. As a result of the Covid-19 pandemic, the Annual Meeting has been postponed and is unlikely to take place before the Autumn, due to the need for strict social distancing measures and the capacity of the Council Chamber. Consequently, the programme of meetings for 2020/21 has not yet been formally agreed.
- 3. This report sets out the schedule of draft meeting dates for the Local Pension Board, as well as for the Pensions Committee and the Investment Panel, for the 2020/21 year.
- 4. If any of these dates need to be changed, this will be reported at future Local Pension Board meetings.

Venues for Meetings in 2020/21

- 5. Prior to the Covid-19 pandemic all meetings were originally planned to take place at the Town Hall.
- However, due to the need to adhere to strict social distancing measures, it has been decided that meetings in June and July 2020 will take place by video conference.
- 7. Decisions on the use of video conferencing and/or the location of later meetings will be made closer to the dates of those meetings and will take into account Government guidance in force at that time. The Local Pension Board will be advised of this, as and when decisions are taken.
- 8. The calendar of meetings for the Pension Fund also includes an annual meeting and two offsite training events. A decision on how to approach these events will also be taken closer to the date, taking into account Government advice and the practicalities in each case.
- 9. The first offsite training event of the municipal year was scheduled for Monday 14th to Wednesday 16th September. However, the Pensions Committee, at its meeting on 11th June, decided to cancel the offsite element of the training. Options around the delivery of an abbreviated event either held locally or via video conferencing are currently being considered. At this stage, the Local Pension Board is asked to keep these dates free until a final decision is taken.
- 10. The dates set out in this report are the same as those provisionally reported to the Local Pension Board in March 2020.
